Snyder Gallery Opening in April

Eight years ago, Historic Rock Ford lost a good friend when renowned antiquarian and scholar John J. Snyder, Jr. died at the age of 67. John had given so much of his time and treasure to the Foundation over the years as Board President, Collections Committee Chair and in the gift of a vast array of period furnishings on display in the rooms of the Hand Mansion. From an exquisite Lancaster County Federal Style dining table to the delicate English Creamware that it holds, John's influence exists just about everywhere at Rock Ford.

Almost a year after John's passing, we received a phone call from Jamie Price, John's longtime friend and an executor of his estate. Jamie wanted to know if our organization was prepared to accept the items from John's collection specific to Lancaster County that had been earmarked for Rock Ford? If we Ann B. Barshinger Welcome Center at the rear of the Barn. were not, Jamie explained, most of these pieces would go to

auction and Rock Ford would be a beneficiary of the proceeds from their sale according to the provisions of John's will.

We had to consider all the consequences of accepting such a sizable collection. The space requirement alone was an enormous obstacle, but John had spent a lifetime gathering and studying important antiquities from Lancaster County and Rock Ford had benefited many times over from his generosity. We simply had to find a way to accept John's final legacy and to find a way to honor the wishes of a man who was instrumental to Rock Ford's success and, just as importantly, we had to keep this part of his collection in Lancaster.

After years of imagining, planning, fundraising, building, renovating, and conserving, we are very excited to open the doors of the John J. Snyder, Jr. Gallery of Early Lancaster County Decorative Arts on Tuesday April 13, 2021. There were times when the logistics of bringing a new gallery space to life amidst a global pandemic presented delays and other challenges but the dedicated project team persevered and are now ready to share John's collection with the public.

Gallery visitors will see Lancaster County tall clocks, furniture, paintings, silver, and more from the period John Snyder himself called the "Golden Age of Lancaster County Artisanship." The Kauffman Collection of Lancaster Long Rifles will also be on display and will help to illustrate one of the Gallery's important themes, the nexus between artistry and utility so common in early Lancaster County decorative arts. An architecturally harmonious addition to the Rock Ford Pennsylvania Bank Barn will serve as a new welcoming point for visitors to the museum.

We have been overwhelmed by the amount of support and encouragement we have received from the Lancaster philanthropic community for this project. We could not be more proud to have received the trust and support of so many and to finally present the gift of the John J. Snyder, Jr. Gallery to Lancaster, a gift they helped to provide. A very special and completely unique donor recognition exhibit piece installed in the Gallery will commemorate their contributions.

The inaugural year exhibit was curated by Lisa Minardi. Lisa is the Director of the Center for Pennsylvania German Studies in Trappe, PA and an author or contributor to several books on the decorative arts of South Central Pennsylvania. She is a graduate of the Winterthur Program in Early American Culture and was a protégé of John Snyder. There was no one better suited to serve as guest curator for this exhibit.

The story of Lancaster County in Early America has too often been overshadowed by larger cities like Philadelphia, New York, and Boston but Lancaster County was an extremely consequential region in the development of our nation. The Snyder Gallery will help to tell its story by highlighting the diversity, industry, artistry, and craftsmanship that defined it.

Rock Ford Board of Trustees Writes Strategic Plans

Former "Head Hostess" of Rock Ford, Ann Taylor **Passes Away**

On January 14, 2021, Ann L. Taylor passed away peacefully at the age of 92. From the early 1970's through well into the 1990's, Ann served as the "Head Hostess" of Rock Ford. During much of this period, guided tours were not given by "docents" or "guides" but, rather, by female "hostesses" attired in period dress. In effect, Ann was Rock Ford's Executive Director for over 20 years, a watershed period which included construction of Kauffman Barn and museum and an unprecedented increase in visitation during the years surrounding the Bicentennial. In June of 1975, she helped to oversee Rock Ford's first major Revolutionary War Encampment and Battlefield re-enactment which was held at Rock Ford to Rufus A. Fulton, Jr. (photo from the delight of large crowds over a Lancaster Sunday News, April 1975) two-day weekend. The 1970's

was also the era of the extremely popular "Tennis and Crumpets" fundraiser for Rock Ford.

According to Steve Trapnell, who served under Ann's tutelage when he was a tour guide during high school and college: "She displayed a heartfelt dedication to Rock Ford, a true love of history, and the ability to make our group of volunteers and part-time staff feel like family... thanks to her leadership, I developed an appreciation for the work of historic sites. She made Rock Ford a rewarding and fun place to work, and I truly value her dedication and friendship.'

As Ann's successor, it is a bit of a strange coincidence that, for the past 14 years, I have lived a few houses down the street from her house. We would frequently exchange waves as a drove by while she sat on her sundeck and I would sometimes stop by so that we could chat about Rock Ford. Until almost the end of her life, she lived alone in the same house that she had occupied with her late husband, Richard, during her Rock Ford years. She retained a vital mind and spirit, and her home remained filled with antiques and books about American history. Ann provides a vivid reminder that all that Rock Ford has become has been built upon the work of those who came before us. She will be remembered fondly, and her legacy will be cherished at Rock Ford.

Ann's family has directed that memorial contributions in her memory may be made to the Rock Ford Foundation.
